




# About the Cambridge Summer Campus

## Admissions

Students may attend either both or just one week of the Summer Campus (Week 1 or Week 2) according to their interests.

### **Eligibility to Apply**

- Advanced undergraduate students (2nd year) in fields of social science such as public policy, politics, economics, international affairs, and legal studies
- Graduate and Postgraduate students in relevant fields
- Practitioners in relevant fields
- All applicants are required to possess strong English Language skills

#### **Admission Procedures**

- Download Application Form\* from our website. Complete, clearly indicating whether or not you are interested in both weeks of the Summer Course, or, just Week 1 or Week 2, and email the application along with the abovementioned supporting documents to <a href="mailto:admissions@csc.eplo.eu">admissions@csc.eplo.eu</a>
- Pay the non-refundable application fee of 50 GBP (banking information to be sent upon receipt of application). Please note that your application will not be examined until we receive payment confirmation of the application fee.
- Applicants will be notified as to the results of their application within a maximum of two weeks of the Admissions Office receiving both complete application materials and application fee.

# Cambridge and Wolfson College

The College was founded by the University of Cambridge in 1965 as University College, changing its name to Wolfson College in 1973 following generous funding from the Wolfson Foundation. The Wolfson College is now a mature institution and plays a full part in the life of the University of Cambridge, both intellectually and also culturally.





The majority of Wolfson students are carrying out research towards postgraduate degrees, in particular PhDs and MPhils, but there also students studying for taught Masters degrees and a number of mature undergraduates. Wolfson has a large and diverse Fellowship of academics working within the University of Cambridge, including about 30 postdoctoral Research Fellows each year, as well as regular academic visitors from abroad, further enhancing the College's international reputation.



# Transportation

### By road:

RAC and AA websites offer up-to-date traffic information and route-planners. From London and its airports: London Orbital (M25), M11 north; from the Midlands or the North: A1, A14, M11 south; from the East: All/A14, M11 south. Look out for Gough Way on your left, closely followed by a safety camera. The College entrance is on your left, shortly after the camera, opposite Grantchester Road and just before the traffic lights at the pedestrian crossing.

### By Air:

London Stansted (40 min) London Luton (1 hour) London City (1.5 hour) London Heathrow (2 hour) London Gatwick (2 hour)

There are regular coach services from these airports to central Cambridge.

### By Rail:

**First Capital Connect** provides a fast and frequent service from London King's Cross and **Greater Anglia** provides a slower service from London Liverpool Street. There are also direct services from the Midlands, the east and the north-west. From Scotland and the north-east you have to change at Peterborough.

### By Coach:

**National Express** runs hourly services to and from London and the London airports, as well as serving many other towns and cities.

The College is located on Barton Road, Newnham Cambridge, within easy reach of London, London's airports and other major cities.
